This dissertation works to reconceptualize identity by locating sites both in social media and geophysical areas where identities overlap and intersect and argues that such locations are areas of strength. As such, I argue that we consider the intersections of identity formed when users move across social media, and across geophysical and locations. Additionally, I view the writing classroom as a site where the reconceptualization of identity can occur by drawing upon identities that move beyond those of student and teacher..
